WHEN: October 2016

The date indicates the information is current and should be more relevant information for a field that is constantly changing with more research.

WHERE: The article was published in <u>Experimental and Therapeutic Medicine</u>, an academic journal out of England written for an academic audience. The journal is published monthly which aims to "ensure the rapid publication, in both print and electronic format, of studies relating to biology, gene therapy, infectious disease, microbiology, molecular cardiology and molecular surgery" (*Experimental and Therapeutic Medicine*, "Aims & Scope"). The journal is published out of England, and appears to be a well-established academic journal.

WHY: This article was written to approach the issue on the risks and complications of childhood type 2 diabetes. It goes over the factors, and the actual studies of the increase of type 2 diabetes in kids. It was written to share research with other researchers and practitioners.

HOW: As a peer-reviewed article it has gone through a double-checking and refining process before its publication that makes it a more credible source.

What makes this source credible?

Although it is difficult to get information on these authors because they are Chinese, the fact that they have this publication in the academic and peer-reviewed journal *Experimental and Therapeutic Medicine* is a sign that this is an article with good information.
